### .OOO Registry Policies

#### 1 .OOO Registration Policies

Updated 18 September 2017

- 1.1 Term. Names may be registered for a period of no less than one (1) year and no more than ten (10) years, commencing on the date on which the Registry accepts the request for registration submitted by the accredited registrar.
- 1.2 Names registered in **.OOO** must have at least 1 character and not more than 63. All 2 (two) character domain names are reserved in accordance with ICANN policy and the terms of its Agreement with ICANN.
- 1.3 Names registered in **.OOO** may contain the 26 letters of the Latin alphabet, "a-z", the ten digits, "0-9", a hyphen, "-", and a dot,".". The dot is used exclusively to separate labels. The hyphen may not appear at the beginning or end of a label. A label may not contain more than 63 characters and the total number of characters in a name may not exceed 255 (including a final dot that is not normally displayed as a part of the name).
- 1.4 Two hyphens may appear in the third and fourth positions in a label in a **.OOO** name only in accordance with the policies and procedures for Internationalized Domain Names (IDN) referenced below.
- 1.5 IDNs may be supported in **.OOO** TLD. IDNs are subject to specific terms and policies set forth by ICANN and/or Registry. The limitations on the length of individual labels and the total length of a name stated in Section 1.2, above, apply to the encoded form ("Punycode") of a name containing characters from the extended range, as further described in the separate IDN documentation.

- 1.7 Mixed scripts are not permitted.
- 1.8 Registry reserves the right to implement additional IDNs in **.OOO**.

- 1.9 Dotless domains are not permitted in the TLD. Dotless domain names are those that consist of a single label (e.g., http://**example**, or mail@**example**). Dotless names would require the inclusion of, for example, an A, AAAA, or MX, record in the apex of a TLD zone in the DNS (i.e., the record relates to the TLD-string itself).

## 2. ACCEPTABLE USE POLICY

OOO provides an abuse point of contact through an e-mail address – oooabuse@infibeam.net. This e-mail address will allow multiple staff members to monitor and address abuse reports. .OOO reserves the right, at its sole discretion and at any time and without limitation, to deny, suspend, cancel, redirect, or transfer any registration or transaction, or place any domain name(s) on registry lock, hold, or similar status as it determines necessary for any of the following reasons:

- a) to protect the integrity and stability of .OOO;
- b) to comply with any applicable laws, government rules or requirements, requests of law
- c) enforcement, or any dispute resolution process;
- d) to avoid any liability, civil or criminal, on the part of .OOO, its affiliates, subsidiaries,
- e) officers, directors, contracted parties, agents, or employees;
- f) to comply with the terms of the applicable registration agreement and .OOO policies;
- g) where registrant fails to keep Whois information accurate or up-to-date;
- h) domain name use is abusive or violates this AUP, or a third party's rights or acceptable use policies, including but not limited to the infringement of any copyright or trademark; to correct mistakes made by a registry operator or any registrar in connection with a domain name registration; or
- i) as needed during resolution of a dispute.

Abusive use of a domain is described as an illegal, disruptive, malicious, or fraudulent action and includes, without limitation, the following:

- a) distribution of malware;
- b) dissemination of software designed to infiltrate or damage a computer system without
- c) the owners informed consent, including, without limitation, computer viruses, worms,
- d) keyloggers, trojans, and fake antivirus products;
- e) phishing, or any attempt to acquire sensitive information such as usernames,
- f) passwords, and credit card details by masquerading as a trustworthy entity in an
- g) electronic communication;
- h) DNS hijacking or poisoning;
- i) spam, including using electronic messaging systems to send unsolicited bulk messages,
- j) including but not limited to e-mail spam, instant messaging spam, mobile messaging
- k) spam, and the spamming of Internet forums;
- l) botnets, including malicious fast-flux hosting;
- m) denial-of-service attacks;
- n) child pornography or any images of child abuse;

- o) promotion, encouragement, sale, or distribution of prescription medication without a valid
- p) prescription in violation of applicable law; and
- q) illegal access of computers or networks.
- r) In addition, as per our commitment made as part of Specification 11 of our registry agreement, no registrant may use a .ooo domain in a manner that might cause confusion with the Australian Triple Zero Emergency Call Service.

### **3. .OOO WHOIS Policy**

Access to WHOIS information is provided to assist persons in determining the contents of a domain name registration record in the TLD database. The data in this record is provided by Infibeam Incorporation Limited (**Infibeam**) for informational purposes only, and Infibeam does not guarantee its accuracy. This service is intended only for query-based access.

You agree that you will use this data only for lawful purposes and that, under no circumstances will you use this data to:

- (a) allow, enable, or otherwise support the transmission by e-mail, telephone, or facsimile of mass unsolicited, commercial advertising or solicitations to entities other than the data recipient's own existing customers; or
- (b) enable high volume, automated, electronic processes that send queries or data to the systems of Registry Operator, a Registrar, or Infibeam except as reasonably necessary to register domain names or modify existing registrations.

Infibeam reserves the right to modify these terms at any time.

### **4. Add Grace period Limits Policy**

#### **AGP (AD GRACE PERIOD) LIMITS POLICY.**

The Add grace period "AGP" shall be restricted for .OOO in the following manner:

- a. During any given month, the ooo TLD Administrator shall not offer any refund to an oooTLD- Accredited Registrar (Herein referred to as Registrar") for any domain names deleted during the AGP that exceed (i) 10% of the Registrars net new registrations (calculated as the total number of net new adds of one year through ten year registrations) in that month, or (ii) Fifty (50) domain names, whichever is greater, unless an exemption has been granted by the oooTLD Administrator.
- b. A Registrar may seek an exemption from the .oooTLD Administrator from the application of such restrictions in a specific month, upon the documented showing of extraordinary circumstances. For any Registrar requesting such an

exemption, the registrar must confirm in writing to the oooTLD Administrator how, at the time the names were deleted, these extraordinary circumstances were not known, reasonably could not have been known, and were outside the Registrar's control. Acceptance of any exemption will be at the sole and reasonable discretion of the oooTLD Administrator, however "extraordinary circumstances" which reoccur regularly of the same registrar will not be deemed extraordinary.

#### **DEFINATION & REVIEW:**

This document has been prepared and published to represent our policy regarding the administrative and technical management of the TLD.

We may discontinue or amend any part or the whole of this compliance statement from time to time at our absolute discretion.

**ICANN** means the Internet Corporation for Assigned Names and Numbers, its successors and assigns.

**REGISTRAR** means an entity that is authorized to offer domain name registration services in relation to the TLD.

**SERVICE** means the services that we provide in relation to the TLD.

**TLD** means top level domain and for the purpose of this policy the TLD shall be .OOO.

**We, us** and **our** means Infibeam Incorporation Limited trading as .OOO Registry or our designated representatives.

**You** and **your** means the person or entity receiving or accessing the service.

#### **ABOUT THIS DOCUMENT:**

This document describes our compliance with the Add Grace Period Limits Policy and defines the process by which a Registrar may seek an exemption. And this document provide a public statement by OOO regarding our Intention to comply with the ICANN Add Grace Period Limits Policy.

#### **WHAT IS ADD GRACE PERIOD?**

The Add Grace Period is the period following the initial Registration of a domain name, and is intended to allow for the no-cost cancellation of domain name registrations resulting from errors by registrars and registrants.

Details about Infibeam Incorporation Limited Domain Name for the oooTLD can be found in the policy section of the Registry's website nic.OOO.

In providing an Add Grace Period, ICANN requires that both Infibeam Incorporation Limited in the management of the .OOO and registrars comply with the Add Grace period Limits Policy.

## **WHY THERE ARE ADD GRACE PERIOD LIMITS?**

Add grace period limits were introduced to provide an upper limit on the number of refunds a Registrar can request for domain names created in error. This limit was needed to protect against potential abuse of this functionality.

Where the limit is exceeded, any additional cancellations may not be eligible for a refund.

The limit in the Add Grace Limit Policy is applied on a monthly basis.

## **EFFECT ON REGISTRARS**

Following notice of the effective date of the policy, Registrars processing AGP deletes during the normal course of business will be subject to the policy and will not receive refunds for AGP deletes that exceed the threshold limits set by the policy, unless an exemption has been requested by the Registrar and granted by the operator, Registrar will be obligated to provide information required by the operators in order to have exemption requests considered.

## **EXEMPTIONS TO THE ADD GRACE PERIOD LIMITS POLICY**

In the application of the Add grace period Limit policy we may grant a Registrar an increase to the threshold imposed for a particular month. An increase may be granted where a registrar has applied to us to request such, and many or may not be granted to our sole and reasonable discretion.

The requests for increase must (amongst other things) describe why the surroundings circumstances were not known, or could not have been reasonably known by the Registrar, at the time the domain names were deleted; and how these extraordinary circumstances were outside of the Registrar's control.

## **EXEMPTION REQUESTS**

At the conclusion of any month, a registrar has until the end of the following month to supply a request for exemption. A request must include the following information:

- Registrar Name
- Registrar IANA ID
- Date of Request
- Date the Domain names were deleted.
- Number of Domain names deleted.
- List of Domain names affected.
- Extraordinary circumstances/ reasons for request.
- A statement that the information in the exemption request is true to the Registrar's best knowledge.

The exemption request must also be accompanied by the relevant fee, if any. Information relating to the particular extraordinary circumstance must be described and provided with supporting documentation. We may from time to time require additional information to process a request for exemption.

## **RECORD KEEPING AND REPORTING**

We will maintain information regarding an exemption request for a minimum of one year, or longer where required to do so. Where requested we may provide such information to ICANN.

We will also provide in our reporting to ICANN for each registrar:

- Number of exemptions requests
- Number of exemptions granted
- Number of domain names affected by the granted exemption request.
